SMAC POLICIES:

Communication:

If at any time throughout the year, you or your child have questions or concerns, we strongly encourage you to speak directly with us or through email at sisu.martial.arts.club@gmail.com

Parent Watch:

Classes are private unless approved by special request by your sensei. Please keep posted for special parent watch days.

Required Gear:

- Martial Arts Gi: Order forms will be available for your Gi after a one month trial of commitment. Please attend all classes in sweat pants or shorts and a dry fit shirt until your Gi has arrived. Gi's come with a White Belt, and progression stripes will be earned.
- Towel for sweat
- Water Bottle

Hygiene:

- Please keep ALL nails clipped for safety reasons
- Wear proper deodorant as you are in close proximity to other students
- Long hair should be neatly pulled back
- Do not wear any jewelry, watches, or accessories
- You are expected to have a clean Gi every class.

Dojo Rules:

- No jewelry or accessories in Dojo
- Do not wear your Gi outside of class
- No gum chewing in class
- Be respectful of your sensei and fellow students
- No profanity or abusive language
- Maintain a calm demeanor and voice
- Keep proper posture
- Address your teacher by using Sensei as the formality
- Follow all Bowing Etiquette
- No running or inappropriate activities are permitted within the Dojo
- Students are required to sweep upon entering or leaving Dojo
- Maintain discipline within and outside Dojo
- Fighting outside of class will result in immediate dismissal from SMAC
- Obey all SMAC rules



Attendance:

SISU participants are expected to attend all classes. If your child is ill and not able to come to watch their class please contact your sensei in person or through email (AS ABOVE). It is not the responsibility of the sensei to re-teach any work and so your child may take longer to reach their testing skills if too many absences are reported. There are no refunds given for absences.

Cancellation Of Classes:

If there is insufficient registration in a class, it may be cancelled and/or substituted. For new classes developing, a minimum of 10 students will be required in order for a class to proceed. Semi private rates may be applied to accommodate a smaller class. **Bad Weather;** If you are questioning bad weather and haven't received an email of your cancelled class, you can also check the SISU Martial Arts Club "SMAC" group page on facebook

Withdrawal From SMAC If Under Yearly Contract:

To withdraw from SMAC a two-week (14 day) written notice must be received along with your doctors note stating the nature of illness or injury. If written notification is not received on time, the next month's fees will be processed. If notice is given in time and is accompanied by doctors note, any post-dated cheques, providing your account is up to date, will be returned. There will be no refund or discount for missed classes. The withdrawal policy is strictly enforced. There is NO refund for tournament or testing fees after December 1st.

Dismissal From SMAC

SMAC reserves the right to refuse registration or terminate a contract by dismissal from the club. For any individuals (students or parents) displaying non-compliance, or undesirable behaviour or non-payment of fees. If this situation arises you will be refunded any money where classes have not been rendered, as well as post-dated cheques that have been submitted, provided your account is up-to-date and no money is left outstanding.

Registration AND Tuition Fees:

SMAC in it's first year trial run is waiving all registration fees. You must pay your FIRST MONTH'S FEES with CASH, E-TRANSFERS, or POST DATED CHEQUES. Please be aware there will be an additional 10% late payment charge for each month the balance remains outstanding. You will be fully responsible for any NSF fees and your child may be dismissed if payments are not up to date.
